Exhibitor Only Package

The exhibitor - basic option includes an exhibitor booth for two people. This package does not include access to the conference meals and other conference events (e.g., presentations; poster reception).

Each exhibit area includes a table that is approximately 6' x 30" with two chairs. A sign - drape can be provided, but for accessibility, we will not put one on the table unless you bring one on your own. The height of all displays must not exceed 10'. The exhibitor shall adhere to decorum and good taste, as well as safety and structural integrity. No exhibitor shall erect any walls, partitions, paintings, decorations, or other types of obstructions, which would interfere with the view of any other exhibitor's booth. Exhibitors will abide by all venue requirements.
